My name is Steven Kramer. I swear and attest to the following:

I have resided in Perrysburg since 1978. I am Professor Emeritus at the University of Toledo, having taught Mechanical Engineering from 1973 until my retirement 35 years later in 2008. Since then I have been a volunteer math and science tutor, first at Perrysburg Heights Community Association [PHCA], and now at Perrysburg High School every day of the week.

I was a member of the PHCA Board of Trustees in 2012 and 2013 and was present at every one of their monthly board meetings in that time frame. Plus, I have read the minutes and treasurer's reports issued then.

Let me first say what I think is quite important: In this letter I am speaking for myself, Steven Kramer; someone present during the time frame in question. Although I am currently still on the board of trustees, I am not representing them nor the Perrysburg Heights Community Association.

About Jason:

I met Harold "Jason" Craig in 2010 and got to know him quite well. I understand Jason Craig was convicted and is presently serving his sentence at ODRC in Mansfield, Ohio. Here are my recollections from memory and from review of the minutes and treasurer's reports.

Jason joined the PHCA board of trustees in late 2011. He became treasurer in July 2012. As treasurer, he handled income from various sources, paid bills, as well as made monthly reports at our meetings. To my knowledge, everyone thought Jason was doing an admirable job as treasurer. At no time did anyone ever think there was a problem with anything regarding finances.

When Jason joined the board in 2011, he was already known among the neighborhood to be a square shooter – namely, calling a spade a spade even if it offended people. Hence he was either liked and admired, or strongly disliked and avoided. Around May or June of 2012 Jason discovered certain financial discrepancies at PHCA and brought them to the attention of the board. [I remember he said he studied finance at Personal Career Development Institute (PCDI) in Canada although he never earned a degree in that subject.] As a result of these discrepancies certain personnel changes were made and Jason became our treasurer by unanimous vote. He served in this capacity well: balancing the checkbook, paying off creditors, correcting errors, collecting money from gym rentals, and so forth. Finally our finances were back on track toward the end of 2012. However, since we had a low bank account balance [not counting an endowment of about \$350,000 which we could not touch], and the person in charge of grant writing was not effective, we needed to raise money. The board created five committees: Education, Medical, Fundraising, Finance, and Beatification & Safety. Jason

became the chairman of the Fundraising, Beatification & Safety, and Financing committees because of his many ideas, his entrepreneurship, and he lived in the neighborhood and wanted it improved. At this time he was already the current treasurer so it was a good fit for him to be head of fundraising and finance. Plus, no one else wanted those responsibilities.

In the meeting minutes from September 2012, it can be seen that the board decided to set aside funds (call it a budget) for the Education, Medical, Fundraising, and the Beatification & Safety committees. Each committee would receive ten percent (10%) of the all money coming into the association with the other 60% going into the general fund account. At this time the board also authorized each committee to be in charge and responsible for their own funds. If at any time a committee needed more funds the head of that committee would address that with the board as a whole.

Jason's Fundraising ideas:

As head of the Fundraising committee, Jason initiated these fundraising projects:

- 1. Selling Speedway fuel cards to make \$5 on every \$100 fuel card sold.
- 2. Purchasing, maintaining, stocking a soft drink beverage machine at the Community Center because we had numerous renters at the gym. Sports make people thirsty.
- 3. Obtaining discounted tickets to several Detroit Pistons basketball games and selling them. Jason also drove kids to the games picking up all travel and parking costs.
- 4. Purchasing "Beats" headphones in quantity and selling them.
- 5. Purchasing \$2,500 worth of "Weight Circles" dog food from different sources [Jason has a big dog]. Jason would purchase the Purina weight circles for up to 80% of its value. He would then redeem them through Purina for 100% of their value in Best Buy gift cards. Upon selling these gift cards, PHCA would receive a 20% profit. Jason gave all profit to PHCA in April 2013.
- 6. An indoor or outdoor Flea Market for \$5 / table was first held on May 4, 2013. It was a big success and very appreciated by residents of the neighborhood. As a result, Flea Markets were held every Friday thereafter.
- 7. And the largest money maker: Purchasing Visalus energy drink mixes from the manufacturer and selling them at a profit.

More about Visalus:

Jason was authorized to purchase Visalus, In order to obtain the products [Visalus, lots of bottled water and soft drinks, gift cards, fuel cards, basketball tickets] at times Jason had to make withdrawals from the PHCA bank account. I don't know if he wrote checks to himself or

did a funds transfer, but money was needed to make money. As head of the fundraising committee and finance committee Jason was authorized to do this. No one ever raised any objections.

At no time did anyone at PHCA suspect or accuse Jason of theft of funds. We saw the monthly treasurer's reports at our board meetings and saw the income and expenses for fundraising. Usually but not always, income exceeds expenses. We all had high praise and admiration for Jason. Unfortunately Jason did not itemize the amounts of money spent for each project. In hindsight, that would have been a good idea.

Treasurer's reports:

The treasurer's reports at each monthly meeting separated the general fund (used to cover operating expenses), the \$20,000 CD which made only a few dollars each month, and the endowment with the Toledo Community Foundation which we could not touch.

At no time after Jason became the treasurer, did PHCA have more than \$71,000 in the general fund. In addition, the account balance was decreasing due to payroll as discussed in the next section.

The month that "something" hit the fan:

In May 2013 around Memorial Day, President Stephanie Serda made a motion to have Jason removed from the board effective immediately. The reason was not clear. What was unusual about this meeting was that it was open to the public, was held in the gym as there were about sixty [60] people from the Heights community in attendance. Although past board meetings were always open to the public, never before had any meeting been attended by people other than board members and invited guests. I believe Anita invited everyone from the neighborhood because she wanted people to witness Jason's removal from the board. Surprisingly, the motion was defeated by a vote of 4 to 3 with 2 abstentions so Jason remained on the board. Jason then made a motion to have Anita Serda removed from the board effective immediately, due to breaking PHCA bylaws concerning the previous vote on Jason's removal. [Apparently, this should have been done in executive session, but it wasn't.] This motion passed by a vote of 4 to 3, also with 2 abstentions. Anita was visibly upset. Actually she was furious. She accused Jason and myself of awful things, and stormed out of the room. Everyone was dumb-founded.

The sabotage of the Mexican-American Festival:

Fast forward 70 days to mid-August and the Mexican-American Festival which PHCA had been hosting every year for decades and Anita had always been in charge. Admittedly, a large task and to her credit, she ably handled the job. Unbeknownst to all but one other board member [her daughter], she was paying herself \$3,500 each year. Jason found this out among the things he discovered when he became treasurer. You can imagine this was a big surprise to everyone when he brought that up at a meeting. The day before the event, our electrician went to turn on the electrical power at the pole but was informed by Toledo Edison our account was

frozen by the named individual authorized to do this: Anita Serda. Also the company who we rented the tent from, received an email from Anita cancelling the rental contract. In addition, an email was sent to Pepsi cancelling their sponsorship of the event. Source of email: Anita Serda. The Health Department received an anonymous call stating that they need to check out the festival vendors. Which they did and found total compliance. Our two headline performers, Tejano Highway 281 and Michael Ybarra, did not show up for the event because they were contacted by Anita Serda and told the event was cancelled. In spite of the sabotage, the festival was held and was a huge success, thanks mostly to Jason. A profit of \$3,000 was made on the two-day event.

In closing:

Regarding the charges against Jason, let me say this: At no time did PHCA have anywhere near the amount of money that he was found guilty of stealing. If Jason was guilty of something, it would be not keeping accurate records of money-in and money-out for the different fund raising projects he spearheaded.

Stephanie and Jason were authorized to write checks and had permission of the board. In our ten-member board of trustees, only three of us were active in the operations and fundraising of the PHCA. These were Stephanie Serda, Jason Craig and myself. President Stephanie Serda and treasurer Jason Craig were authorized to write checks and had permission of the board to make any fundraising and financial decisions. I chose not to get involved in that.

Why didn't I testify at Jason's trial?

I was never contacted by Jason's attorney or anyone connected to this case to testify at trial last year. If I were told to appear I would have been totally supportive of Jason.

In closing, let me say, Jason is among the few men I have met who is a genuinely good person and who goes out of his way to make a difference in people's lives....mostly kids.

I don't know if any of this is helpful.

My name is Jesse Spier. I swear and attest to the following:

This letter is written to address the charges that were brought upon Harold "Jason" Craig stemming from his involvement with the Perrysburg Heights Community Center. First, a little background about my relationship to the center as well as Jason. I run Toledo Sport and Social Club, a business that offers recreational sports play to adults in and around the Toledo area. In August of 2012, my relationship started with PHCA as a renter of the facility for an adult basketball league. My renting continued until the Winter of 2015. In that time, I paid roughly \$31k in rent for the facility. During this time, I got to know Jason well. Jason is definitely an interesting person. There is no "hustle" that does not interest him, but that is just it about Jason. He is willing to work whatever system is in place to earn a buck, but I truly honestly doubt he would ever take something from someone without providing something in return and therefore, I do not believe he stole from the community center. I believed that so much that even after our relationship at the center ended and he moved temporarily to Cleveland, Ohio, I rented one of my condos to him. During the time he was renting from me, I never had to worry about the rent being paid and he was a model tenant. The charges brought upon Jason do not make sense to me on several levels. First and foremost, having spent an amount of time on the board and as president for a little bit, there was not a surplus of money to be stolen, let alone, even pay the bills. During my time on the board, I paid attention to what was being paid for our utilities and our revenue streams. For the most part, there was revenue from facility rental (mine as a renter) and a few other small events. In addition to the facility rental money, there was the Toledo Community Foundation Endowment money, but we were only allowed to withdraw at most \$30k a year... Honestly, I do not know the terms or how we could reach that money but the balance in the TCF funds never dropped by anything significant during my time, so I am not sure we even withdrew from it more than maybe once.

The second reason and one that I never dug into, but I believe is the error in this process is simply accounting. The Visalis sales were before my time but as I understood the process, product would be purchased and then sold right away. The money made from the sales of Visalis were put right back into product turnover. The only money generated in surplus of purchasing product was through commissions paid by Visalis for making sales goals and being a "distributor". If anyone should be upset about the set-up Jason had put in place with Stephanie Serda and others, it would be Visalis. They were paying commission to distributors who had distributors under them helping the pyramid make more on commission. When it comes to the Visalis "stuff" I can certainly say I do not know all or even a partial amount of the details. However, I believe in the time the attorney general was contacting me, I was being shown only the sales side of the transactions and not the funds being put right back into purchasing product to sell again.

That all being said, I am still confused and mystified that this process has led to a conviction of Jason. I didn't step forward to defend or condemn Jason in the past because I have no proof to show either way. But what I can say for certain, is that there wasn't extra money around the community center when I was there, and I sincerely doubt Jason could have stolen the money he was charged with stealing.

Our names are Paul and Teresa Martinez. We swear and attest to the following:

We were both members of the board for the Perrysburg Heights Community Association during part of the time that Harold Jason Craig spent time on the board as well. Concerning this case and his charges, we do not believe in any circumstance that Jason had stolen any money from the PHCA.

In Jason's early part of his time on the board, it was brought to our attention some errors and discrepancies of funds being used. These concerns included members Anita and Stephanie Serda (our family members) who were in fact wrongfully using funds. Paying themselves outrageous paychecks to be in charge of the PHCA. There was one board meeting where anyone could attend, thus including many of the neighborhood residents, Anita had attempted to have Jason removed from the board in front of the entire crowd. (Including many of Stephanie and Anita Serdas friends and family). With that being said, her attempt failed, and Jason had the support of the board. Following this vote, the executive session was called and Jason madde a motion to have Anita Serda removed from the board. The vote was in favor of having Anita removed from the board immediately, we were in fact two of the deciding votes for her time to end. This had caused many issues with those two members which later led to instances of sabotage and further issues.

Jason took charge of multiple things throughout his time on the board. Jason was head of the finance committee, fundraising, daily operations, and was treasurer of the board. As treasurer and head of the finance committee he obviously came in contact with most if not all of the PHCA's finances, which were barely enough to keep the community center up and running. Every board meeting there were meeting minutes and treasurer reports provided. This showed us board members where any and all PHCA's money was being spent. Seeing these reports each month, and having the ability to look at the bank accounts at any time, no member of the board, including ourselves, ever questioned where the money was spent during or after Jason's run as treasurer. Fundraisers and their progress were brought up and talked about at board meetings, that way everyone was aware of how they were doing and what the outcomes were being.. Throughout all fundraisers, including Visalus, reports were shown to us so we know where all funds were coming and going. We also understood the process of Visalus and the different accounts being used. Once again no accusations of theft were made or suspected from any one of us, as we were all kept in the loop of all funds.

As far as the trial, neither the prosecutors office nor Jason's attorney reached out to us at any time. Again, neither one of us were ever contacted to testify to our knowledge of what occurred through all of these events. Though we may not know every detail or all of the specifics, we sure would have been very helpful in explaining what we did play a part in. When we heard a trial was being brought about, the both of us truly expected to be subpoensed. We were shocked when we heard of Jason's conviction and came to find out we were not involved. If we would have been then we would have been more than willing to supply any information needed. We most definitely would have had Jason's back.

As previously stated, throughout this letter, all of Jason's time spent with the PHCA, and even looking back afterwards we would never accuse Jason of stealing any funds. Especially the funds that we never had in the first place. He worked very hard to bring in enough funds just to keep the building open. The amount that the prosecution has accused him of stealing is baffling, and guite ridiculous. This case seems to be pulled out of thin air, as it would be hard to steal funds that simply put, never existed.







Ex-Perrysburg Township nonprofit leader indicted on corruption charges

The former head of the Perrysburg Heights Community Association is facing several felony charges as he stands accused of mismanaging nearly \$240,000.

Jason Craig is charged with one count of engaging in a pattern of corrupt activity, one count of aggravated theft, and four counts of money laundering. The Wood County Prosecutor's office issued an indictment Sept. 20, and Mr. Craig was arrested Sept. 27 by the U.S. Marshals Service.

The indictment details multiple offenses alleged to have occurred between 2012 and 2015. A message left Wednesday with a public

Mr. Craig was arraigned Monday in Wood County Common Pleas Court, where bond was set at \$25,000. He posted bond Tuesday, according to the prosecutor's office.

In an interview and a press release, Wood County Prosecutor Paul Dobson said investigations into Mr. Craig began in the summer of 2014 after a failed hip-hop concert and lease violations left the center facing eviction from Perrysburg Township.

Headline acts at the center's hip-hop festival, including members of Bone Thugs-N-Harmony, Coolio, and Naughty By Nature, failed to show up. In some cases, promoters and agents said their performers were never contracted to appear. Organizers refused to offer refunds for the \$20 tickets sold for the show.

Mr. Craig blamed a booking agent for the failure of advertised acts to appear.

At the time, former president and founder of the board Anita Serda called for an investigation into Mr. Craig's actions.

Complaints also were sent to the Ohio Attorney General's office in 2013 that Mr. Craig and others were receiving personal gain from the nonprofit.

The indictment lists a number of financial transactions Mr. Craig is alleged to have committed. For instance, the indictment says that on Dec. 19, 2012, he withdrew \$25,000 from the association's Key Bank account, and on the same day deposited \$25,000 into a personal account at Huntington Bank.

The Ohio Attorney General's Office charitable law section conducted an initial investigation soon after the failed concert and sent the results to his office, Mr. Dobson said. An investigator there then conducted a lengthy review of the association's finances before the information was submitted to a grand jury.

"The financial investigations can take a long time," he said.

In his statement about the case, Mr. Dobson said the indictments show he would "hold accountable those who abuse the trust of the public when they are placed in positions of authority, especially over funds entrusted to them by those who willingly donate to not-for-profit organizations."

Paul Belazis, Perrysburg Heights Communication Association board president, said he was surprised by the indictment and



the association's name. The 2013 complaints sent to the state include an accusation Mr. Craig and others gained a profit from weddings and other events rented at the center.

"The association has never really had that kind of money sitting around," Mr. Belazis said in regard to the large amounts Mr. Craig is alleged to have stolen. "I don't know if that would be considered association money, but I would be very surprised that the association had any substantial amount of cash at that point of time."

While Mr. Belazis said he did not know how the association handled its finances before he joined the board in recent years, he said the board uses "careful procedures" when it comes to check signings and other financial transactions.

He added he hopes the indictment doesn't tarnish the reputation of the association, listing off its many community programs such as early childhood education, reading interventions, summer enrichment, recreation, and holiday events.

"All I can tell you is what we are doing now and what we planned to continue doing in the future," Mr. Belazis said.

The total amount of PHCA money spent on Visalus was \$140,417.75. Outgoing funds for Visalus were located in the PHCA PayPal account, KeyBank account ending with medical account. The total amount of incoming funds that were designated as Visalus was \$193,642.27. All incoming Visalus designated funds were located in the PHCA PayPal account with the exception of one check. There is a potential profit on Visalus products of \$53,224.52.
