Response to Civil lawsuit Case#2014CV0520 JUDI
D&W Development vs Kristie Koester & Harold Craig

For almost a year Mr. Craig has hand delivered payment to Mr. Celley at the Perinspurge Township offices. These payments have been based on Walt Celley's availability. This particular month Walt chose not to accept payment at the building and asked that it be mailed to Sanderson Law Office. This request was on the 5th of September (through text message) and payment was mailed on the 7th of September. This is the month that D&W has chosen to take the opportunity to default the mortgage. According to our checking account, this check has not been cashed.

The check from Octobers payment was cleared on October 7th, 2014. This check was delivered to the door mailbox at Sanderson Law Offices. (Exhibit A)

The check from November has yet to be cashed and also was dropped of in the door slot at Sanderson Law Offices.

Facts according to our understand of mortgage law in Ohio

- *D&W is to inform Mr. Craig and Ms. Koester of default according to section 5313.05 Default of Vendee under the Ohio revised code. Not only did the vendor ignore the rights of the vendee by not providing notice of default, vendee was neglected the right to cure the default within the 30 day time frame required by law.
- *According to ORC 5313.02 sec A line 2. Mr. Craig and Ms. Koester was to be provided a copy of a contract signed by both parties. The contract has no signature from D&W thus making it a non binding contract.
- *According to ORC 5313.03 Vendor is required to send a biannual statement to Vendee. In the six years of the contract the Vendor has not sent this statement 1 time. The Vendor has also never sent a 1098 Mortgage interest form for tax purposes for Vendee, even though Vendee made the request (exhibit B)
- *ORC 5313.06 section C No notifications.
- *Ohio administrative code 109:4-3-27 under consumer protection (No reasonable probability of Payment) Mr. Craig has been unemployed since 2003. Mr. Celley required signature from both Mr. Craig and Ms. Koester. Law prohibits D&W to enter into this contract with Mr. Craig due to No reasonable probability of Payment.
- *Terms of this mortgage are unconscionable- Section 4 part B of the Mortgage states that the if the borrower is in default and the lender does not default at the time, the may do it at any

time in the future. This in our opinion is what D&W is doing. Do to a separate issue that is defined later in this response. D&W is defaulting on the loan as retaliation.

*(Exhibit C) are the emails I sent to Gary Britten a Perrysburg Township Trustee explaining that I believe that Walt Celleys attack on the Perrsyburg Heights Community Association was strictly based on his personal issues he has with Mr. Craig. You will find emails from Mr. Celley showing him threatening to start "slamming" him on the web and that Ms. Koester and Mr. Craig need to "beg" for promised mortgage extensions (exhibit D). This at best is harrassment by Mr. Celley and Celley & Sanderson LLP. Upon a voice mail from Mr. Craig telling Mr. Celley that he can't harass them like that Mr. Celley response in a recorded voicemail was that they are not a mortgage company and Mr Craig is incorrect on the legalities of the harassment. Mr. Craig can provide voicemail for the courts. Mr. Craig and Ms. Koester feel that this breaks state and federal consumer protection laws.

*(exhibit E) Emails from Mr. Celley directly harassing Mr. Craig about the community center. The first email shows Mr. Celleys premeditation in his efforts to revoking the lease to the Perrysburg CC. Notice his communication is not directed to the Perrysburg heights community association, its board of directors, or its president. It is directly sent to Mr. Craig at his personal email. In the second email, you will see that the same is true. Mr. Celley directly communicates with Mr. Craig with what seems to be the threat of criminal charges. Once again this is not sent to the PHCA who was the Venue for the festival.

For over 5 years Walt Celley has used his position as an attorney with Celley & Sanderson LLP., D&W Development, and as the administrator for Perrysburg Township to harass and humiliate Mr. Craig, Ms. Koester, & recently has used that vendetta to victimize the Perrysburg Heights Community Association. Mr. Celley is willing to destroy the reputation of Mr. Craig, Ms. Koester, and the board of directors by continuing to harass today.

We hope that the courts finds that D&W Development at the hands of Walt Celley has bullied and harassed the defendants from the early days of this contract. We hope that the court void the contract and allows compensation to the defendants for the abuse they have endured at the hands of D&W Development, Celley & Sanderson LLP, and Walter Celley Perrysburg Township Administrator. Ms. Koester has worked hard to provide for Mr. Craig and her 2 children. For this orchestrated retaliation and harassment by Walt Celley and D&W Development Mr. Craig and Ms. Koester no longer feel comfortable with this arrangement and hope to be able to recoup expenses incurred refurbishing the trailer located on the land. We hope that the court would also send a message that this type of harassment cannot continue by Walt Celley in all three of his roles.

Over the last six years Mr. Celley and I have had tons of conversations about the Heights and the center. All of them have always been pretty tame. We have talked about both his and my thoughts about the last leadership and even how he feels the township should not have a hand in running a community center. We have even discussed PHCA putting together a proposal to purchase the land from the township due to a grant it gave for over \$100,000 in the 90's.

I never thought Walt's conversation made me believe that he hated this neighborhood. However, earlier this year he made a statement to me about a shooting in the neighborhood and "to bad the shooters did not have better aim" was his comment. This is a strong comment and I am willing to take a polygraph to substantiate my claim.

The comment in itself may have been made because 2 dudes were talking and may have been a joke. However, with the culmination and history of steps that I believe he has taken to make the existence of the PHCA as difficult as possible, I have to wonder if his true thoughts were spoken. Since, becoming the solicitor Mr. Celley has convinced the trustees not to donate to the center due to us not providing proper info (which township would have if they fulfilled their part of the lease by providing a board member). He made it clear that you did not want the summer school on the agenda in an email. Of course it made it on because people more important that Heights residents asked for it to be on. All of the recent emails and refusal to work on a solution show me he has no interest in the center becoming a well oiled machine. I have my idea of his motivation but if it is worth ruining all that goes on there for a personal grudge, that needs to be exposed.

All of these are my personal thoughts, none of them are the opinion of the PHCA or this neighborhood. I want the center and neighborhood to prosper. I do think that finding another organization or people to sacrifice their time for 0 pay will be impossible. I want an answer on what needs to happen. I have no interest in hurting anyone or causing anymore drama, but I do have interest in defending a good community center and its supporters against what I feel is a personal campaign.

I am not sure if the trustees are aware but Mr. Celley has several conflicts of interest with current and previous board members.

Previously Mr. Celley was the attorney of Anita Serda, I believe in her divorce, this currently has no impact on the PHCA or township business but has never publicly be disclosed.

Currently Mr. Celley and I have a financial arrangement in which I am purchasing property in the Heights off of him and Dawn Sanderson. As you see below, Mr. Celley has conflict with me personally which I believe is directly responsible for the issues he has created with the association. As you see he threatens to "slam" me on the web and tells me I would need to beg for promised extensions.

You will see in further emails he has established a pattern of what I consider as threats towards myself and premeditation for the default of the PHCA lease due to his long standing personal feud with me.

On several occasion in the last 3 years I have approached Walt, John Hrosko, and the ladies in the office to become members of our board of directors. I was first told by Walt that Hrosko was supposed to be on as administrator, I invited him to no avail. When the township hired Walt as administrator, he was also invited. This part exempts from seating.

(1) This section does not apply to a live entertainment performance held in a restricted entertainment area if one admission ticket entitles the holder to view or participate in three or more different games, rides, activities, or live entertainment performances occurring simultaneously at different sites within the restricted entertainment area and if the initial admittance entrance to the restricted entertainment area, for which the ticket is required, is separate from the entrance to any specific live entertainment performance and an additional ticket is not required for admission to the particular live entertainment performance.
